
ORDER

1. As per reference (1) cited above, Dr. Linto Alappat, Assistant Professor, Dept. of Geology & Environmental Science, Christ College, Irinjalakuda, Thrissur submitted a proposal seeking financial assistance for conducting 'National Conference on Geology: Emerging Methods and Applications (GEM-2017)' scheduled to be held during 6th to 8th February 2017.
