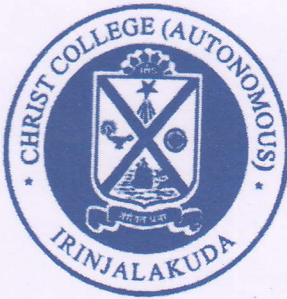

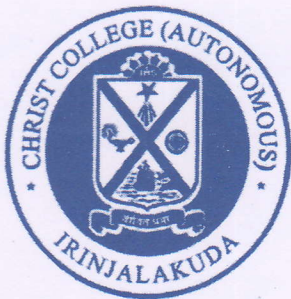

2. MEMBERS- Two female teachers- Representing teaching Faculty

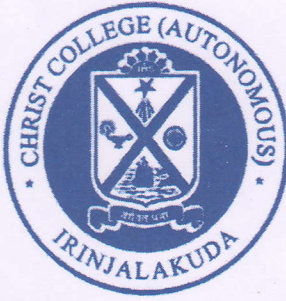
