AGREEMENT RENEWAL

This Agreement of consent made on 6th Dec 2021 by and between **Fr.Dr. Jolly Andrews CMI**, Principal, Christ College (Autonomous), Irinjalakkuda, Thrissur (hereinafter called **Principal**) of one part and Scoreline Sports Pvt Ltd, is represented by Mr. M. A. Laurance (hereinafter called **Scoreline Manager**) of another part.

Whereas the Principal hereby granted the permission to use the ground of Christ College (Autonomous), Irinjalakuda, Thrissur, for the football coaching for a period of one year with effect from 1st Dec 2021 till 30th Nov 2022 to Scoreline Sports Pvt Ltd for conducting football coaching camp.

Now, therefore, this agreement is as follows :-

- SCORELINE will conduct 2 coaching sessions per week morning or evening (Saturday and Sunday).
- 2. The College management should inform Scoreline regarding the unavailability of the ground for any particular session, at least 3 days in prior. In such case Scoreline to be provided any other day/days to compensate
- 3. Football coaching will not affect the normal functions of the College and whenever the College requires the said football ground for College's or management's purposes, the Principal has the right to suspend the football coaching on such days with prior intimation to Scoreline Sports.
- 4. Scoreline Sports Pvt Ltd shall not transfer the permission of football coaching in the ground to anyone else.
- 5. Scoreline Sports Pvt Ltd, shall not carryout any work or alteration in the ground without the written consent of the Principal.
- 6. Scoreline Sports Pvt Ltd, shall not use the ground for any other purpose other than only providing the football coaching/football tournaments/matches.

- 7. The financial and administrative responsibility of the coaching program is completely vested upon the SCORELINE Sports Pvt. Ltd., and the Principal shall not be responsible in such affairs at any cost.
- 8. The Principal has agreed to provide a secured storeroom to keep the balls and other training equipment in the College.
- 9. Either party can terminate this agreement before the expiry of the agreed period by serving the other party with a two month advance written notice of termination.
- 10. If the College management is satisfied with the training program or if interested can renew the agreement for the upcoming years.
- 11. The handshake on the financial part between the Christ College (Autonomous) Irinjalakuda, Thrissur and Scoreline will be as follows.

Considering the benefit of the College management, Scoreline will pay Rs. 3000/- every month as monthly ground rent to the management of Christ College (Autonomous).

This Agreement of consent is prepared in duplicate and original shall be retained with the Principal and the duplicate shall be given to Scoreline Sports Pvt Ltd.
