## Memorandum of Understanding

Between PACHYDERM TALES CONSULTANCY And CHRIST COLLEGE (AUTONOMOUS) Irinjalakuda, Kerala

This agreement is made this 10th day of June, 2020 between Pachyderm Tales Consultancy (hereinafter First Party) and Christ College (Autonomous), Irinjalakuda, Kerala (hereinafter Second Party).

### ARTICLE 1: SCOPE OF COLLABORATION

- Technical supports whenever necessary
- Skill based certification courses that are left to the choices of both the parties
- 1.2 Any specific activity developed under this MOU shall be communicated, which will describe the scope of the proposed activity, intended outcomes, budget, and responsible departments or individuals.
- 1.3 All activities shall be subject to the availability of funds and the approval of each institution's authorised representatives.

# ARTICLE 2: DURATION AND EVALUATION

2.1 This MOU shall be in effect for a period of 10 years from the last date of signature. Either party may request termination of this agreement, in writing, ninety (90) days prior to the proposed termination date. Any activities in progress at the time of termination shall be permitted to conclude as planned unless otherwise agreed in writing.

- 2.2 A joint evaluation of the MOU will be initiated by the designated representatives six (6) months prior to the expiration date. Following the evaluation, the MOU may be renewed and resigned for an additional five (5) year period.
- 2.3 Amendments to this MOU may be requested, in writing, by either party and approved by the authorised signatories.

#### ARTICLE 3: DISCRIMINATION

The parties agree not to discriminate on the basis of religion, race, creed, national or ethnic origin, sex, age, handicap, political affiliation, sexual orientation and disability

#### ARTICLE 4: USE OF NAME

None of the parties shall use the name, logo, likeness, trademarks, image or other intellectual property of either of the other parties for any advertising, marketing, endorsement or any other purposes without the consent of an authorised representative of the other party as to each such use.

#### ARTICLE 5: REPRESENTATIVES

For the sake of convenience representatives has been appointed by both the institution and Dr. R. Lakshmi Priya, CEO and Founder of Pachyderm Tales Consultancy will represent first party while Dr. K. J. Vargheese, Associate professor of the English will represent second party

#### ARTICLE 6: SETTLEMENT OF DISPUTES

Any dispute concerning the interpretation and/or application of this MoU shall be settled amicably through consultation or negotiation between the parties.
