ORDER

1. Kerala State Council for Science, Technology & Environment (KSCSTE) is operating a research fellowship programme for the toppers in M.Sc./M.Tech. courses from the Universities in Kerala to carry out research work leading to Ph.D. Ms. Atheena Amar K was selected for the KSCSTE fellowship during the year 2018 in Life Sciences. The first-year fellowship was released vide reference (2).

2. As per references (3) and (4) the Council enhanced KSCSTE Research fellowship to Rs.31,000 /- per month for the first two years and Rs.35,000/- per month for the third year along with HRA and an annual contingency of Rs.20,000/- with effect from 01.01.202. The fellow has submitted duly signed T&C, Letter from hostel warden and concerned guide for availing HRA for enhanced fellowship.

3. The second year fellowship period is 02.08.2020 – 01.08.2021. An amount of Rs. 4,29,200 being the second year grant (Rs.3,72,000/- towards the fellowship grant @ Rs.31,000/- per month + Rs.37,200/- towards HRA+ Rs.20,000/- towards annual contingency).

4. The fellow is eligible for the enhanced fellowship from 01.01.2020 to 01.08.2020. The arrear fellowship for first year is as detailed below:

5. An amount of Rs.4,98,819 /- (sum of second year fellowship Rs. 4,29,200/- and first-year arrear fellowship Rs. 66,619/-) is to be released as the second-year grant and first year arrear grant.

6. An amount of **Rs.4,98,819 /-(Rupees Four Lakh Ninety Eight Thousand Eight Hundred Nineteen Only)** will be released as the fellowship grant for the second year grant along with first year arrear by means of Electronic Fund Transfer (NEFT) as per their bank details given below in favour of **The Principal, Christ College (Autonomous), Irinjalakuda. The expenditure in this regard will be met from the Council fund under III Schemes and Programmes of KSCSTE 4(a) Research Fellowship.**
