Some of the major suggestions derived from the collected feedback encompass a wide range of aspects within Christ College. The institution is committed to incorporating these insights into its practices to ensure a dynamic and continually evolving educational environment.



Suggestions made by:

STUDENTS

Suggestions on curriculum feedback from PG Students

- PG students recommend more frequent updates to the syllabus to ensure it remains current and aligned with evolving industry trends and advancements.
- Students suggest incorporating additional opportunities and options in the curriculum that specifically prepare them for advanced studies and research.
- There is a desire for improved provisions for research fostering a more comprehensive and interdisciplinary approach to academic exploration.
- Students emphasize the importance of practical exposure by advocating for more internships and field visits, providing them with real-world experiences and insights into their chosen fields.
- There is a collective call for more industrial exposure within the curriculum to better prepare students for professional settings. This includes regular industrial visits, with a minimum of one visit per year.

Suggestions on curriculum feedback from UG Students

- Students suggest updating the course content more often to make sure it stays current with the latest information and trends.
- UG students want more options in their courses that can help them if they decide to pursue further studies after graduation.
- Students suggests to have internships and visits to real workplaces to get practical experience and a better understanding of their future careers.



- Add more Career-focused Classes: They feel that classes focusing on career achievements and skills would be beneficial for their professional development.
- Increase Exposure to Industries: UG students want more exposure to real-world industries, suggesting more visits to companies, with at least one industrial visit per year.
- Promote Rational Thinking: They recommend incorporating a thread in the syllabus that encourages logical thinking and a more scientific approach to problem-solving.

TEACHERS

- External Exposure and Research Opportunities: Facilitate field visits, industry tours, and collaborations with professionals.
- Practical Training and Experimental Learning: Integrate hands-on activities, experiments, and projects into the curriculum.
- Incorporate more active learning strategies such as discussions and problemsolving exercises.
- Increase the duration of internships for a more comprehensive practical experience.
- Foster partnerships with industry leaders to align internships with industry practices.
- Revise the syllabus to include more practical and application-oriented topics.
- Collaborate with industry experts to identify key skills for professional success.
- Establish a systematic process for regular reviews and updates in syllabus Review.



- Involve industry professionals and alumni in the review process.
- Create innovation centers or incubators to encourage creative projects.
- Include the latest developments and research findings in the curriculum.
- Foster collaboration between faculty and researchers for updated content.

ALUMNI

- Alumni recommend an enhancement in the quality and frequency of industrial visits. These visits should be curated to provide students with practical insights into real-world applications of their academic knowledge.
- It is suggested that the institution maintains and improves the quality of classroom teaching. Alumni emphasize the importance of engaging and effective teaching methods to ensure a comprehensive understanding of the subjects.
- Alumni advocate for giving more importance to extracurricular activities as part of the learning experience.
- Alumni proposed a more field-oriented syllabus that integrates practical skills with theoretical knowledge.
- It is recommended to introduce additional practical learning options within the curriculum. This could involve hands-on projects, case studies, and interactive sessions that allow students to develop practical skills alongside theoretical understanding.



- Alumni suggest the provision of internship options to expose students to
 professional environments and hands-on experiences. Internships can provide
 valuable insights into industry practices and help students apply classroom
 concepts in real-world settings.
- To support academic growth, alumni propose making a broader range of reference materials available. This includes textbooks, online resources, and research materials that can aid students in exploring and deepening their understanding of the subjects.

EMPLOYERS

- Integrate technical knowledge into the curriculum.
- Ensure regular updates and relevant modifications in academic content.
- Incorporate more employable skills and practical know-how in the syllabus.
- Increase the inclusion of practical sessions in the academic program.
