MEMORANDUM OF UNDERSTANDING (MoU)

BETWEEN

THE CHARTERED INSTITUTE FOR SECURITIES & INVESTMENT (CISI)

AND

Christ College (Autonomous)

AND

FINMARK TRAINERS INDIA PVT LTD (Finmark)

This Memorandum of Understanding (hereinafter referred to as "MoU") is made between:

The Chartered Institute for Securities & Investment (hereinafter referred to as "CISI"), having its main office at 20 Fenchurch Street, London, EC3M 3BY;

Christ College (Autonomous) (hereinafter referred to as "CHRIST COLLEGE") for and on behalf of its Department of Management Studies and Department of Commerce having its main office at P.O Irinjalakuda North 680125, Kerala State, India; and

FINMARK TRAINERS INDIA PVT LTD (hereinafter referred to as "Finmark"), having its corporate office at No.19, Shanti Nagar, Rajagiri P O, South Kalamassery, Kochi, Kerala- 683104

Hereinafter referred to individually as "the Party" and collectively as "the Parties".

Whereas

CISI is the leading professional body for securities, investment, wealth and financial planning professionals. Formed in 1992 by London Stock Exchange practitioners, we have a global community of circa 45,000 members in over 100 countries and last year more than 40,000 CISI exams were sat in 81 countries, 15,000 taken outside the UK.

Christ College was started in 1956, by the Devamatha Province of the Carmelites of Mary Immaculate (CMI), an indigenous religious congregation founded in 1831 by Saint Cyriac Elias , A Religious Priest and versatile genius , who envisioned education as a tool for liberation and development. Founded as per the provisions of the Indian Constitution, part III, Article 30(1) and administered by Christ College Educational Society, (Regd. No. 137/75), this college is a Minority institution, affiliated to Calicut University and Re-accredited by NAAC with highest grade 'A'. Christ College is dedicated to Jesus Christ, and has as its motto "Jeevitha Prabha", which means "Light of Life". Following recomendation from state government, The college has been conferred the "Autonomous status" by University Grants Commission(UGC) during the year 2015, the Diamond Jubilee year of the college . Christ College is part of a century-old tradition of CMI education that is at its heart, Christian and specifically catholic. It offers an ideal vision of education that is aware of and responsive to the challenges of the nation's present situation.

Finmark is a leader in Financial Market Education. Since its inception in 2010, Finmark has conducted over 4500 training programs across India and the UAE. It offers various programs for Schools, Colleges, Corporates and the public at large. Finmark is an Accredited Training Partner of the CISI.





The Parties wish to collaborate over the offering of CISI Professional Refreshers to students studying for relevant programmes at CHRIST COLLEGE, as outlined herein.

Effective Date

This MoU will be considered effective as of the date of signing by the Parties (hereinafter referred to as the "Effective Date") and is valid for a period of three (3) years from the Effective Date.

The Parties hereby agree as follows:

1. Background to the Agreement

- 1.1 The Department of Management Studies and Department of Commerce at CHRIST COLLEGE, the CISI and Finmark have established a special relationship with the intention of advancing education. In establishing this relationship, students of CHRIST COLLEGE will have the opportunity to achieve CISI qualifications as a compliment to their Academic degrees
- 1.2 The CISI's four Professional Refreshers (PR) will be offered to CHRIST COLLEGE students
- 1.3 Under this MoU, training for CISI Professional Refreshers will be delivered by Finmark to students studying at CHRIST COLLEGE; this will be actively promoted by CHRIST COLLEGE, and embedded by CHRIST COLLEGE where possible.
- 1.4 Additional CISI qualifications may be added to the list with the consent of all the three Parties if there is sufficient demand from the students.
- 1.5 If no students sit the CISI exams during a period of 12 months, the CISI will review and potentially terminate the MoU.

2. Study and Training Support

- 2.1 Students who register to sit any of the qualifications outlined in this MoU will receive access to four Professional Refreshers:
 - Financial Planning
 - Cryptocurrencies
 - Blockchain
 - Artificial Intelligence
- 2.2 Finmark who is the Accredited Training Partner for CISI will bring its expertise in training the selected Professional Refreshers for all the candidates enrolled in this program.
- 2.3 Finmark will be responsible for delivering around 30 hours of training.
- 2.4 Finmark will help CHRIST COLLEGE in creating a centre of excellence for financial operations and encourage candidates in developing the required expertise as per the industry requirements. This will be done only if there are More than 200 CISI exams level 3 exams every year.
- 2.5 Finmark to leverage its large global corporate financial institutional clients in creating internship and final placement opportunities for the students at CHRIST COLLEGE





3. Booking

- 3.1 Finmark will administer the bookings on behalf of CHRIST COLLEGE for its students
- 3.2 CISI will develop a bespoke exam booking form for this partnership which CHRIST COLLEGE will complete and send to CISI
- 3.3 Students trained by Finmark & CHRIST COLLEGE shall make the payments for the Professional Refreshers directly to Finmark. Should CISI not receive payment for any candidates, CISI retains the right to withhold their result
- 3.4 CISI will nominate a relationship manager and an administrator from its Customer Support team to make exam bookings

4. Fees

4.1 CISI will charge a total fee of 5000 INR for all the four Professional Refreshers which will include training by Finmark. Professional refresher will be 20GBP which is included in the above price.

5. Testing

5.1 All qualifications covered within this MoU are tested by multiple choice questions via computer-based-testing (CBT) at nearby prometric centre. Following classroom training, candidates can study at their own pace and test when they are ready. Results are instant and displayed on screen

6. Marketing and Promotion

- 6.1 CHRIST COLLEGE will actively promote the value of CISI qualifications to students on relevant programmes, and will encourage students to sign up for the CISI exams
- 6.2 CHRIST COLLEGE will list details of the partnership with CISI on their website, including the CISI logo, and will share a link of this with the CISI
- 6.3 CISI will enable CHRIST COLLEGE to use the CISI Education Partner logo to market the partnership, subject to the logo guidelines
- 6.4 The Marketing Department of the CISI will be able to support the Marketing Department of CHRIST COLLEGE to ensure the appropriate level of market and promotion of the collaboration to drive demand for CISI qualifications
- 6.5 CHRIST COLLEGE will be responsible for providing platform and access to its campus for CISI to promote the CISI, the International Certificate In Wealth and Investment Management (India) qualification and any other certification agreed upon in due course
- 6.6 CHRIST COLLEGE Shall provide platform and access of its campus to Finmark (the accredited training partner of CISI) to train and assist the candidates enrolled for this program required to achieve desired success

9. Intellectual Property

- 9.1 The intellectual property of all other CISI qualifications, study materials and any translation remains, at all times, the property of the CISI
- 10. Confidentiality





10.1 Each of the Parties will keep confidential (both during and after the termination of this agreement) all information concerning the operations of either party which is obtained or received as a result of the entering into or the performance of this agreement unless the information is in the public domain or the disclosing party is under legal obligation to disclose the information

11. Variation

11.1 No addition to, or modification of, any provision of this agreement shall be binding on either party unless made in writing and signed by duly authorised representatives of the three Parties

12. Assignment and Sub-contracting

12.1 No Party shall be entitled to assign its rights and obligations under this Agreement to a third party without the prior written consent of the other Parties and, in the case of a proposed assignment to a third party that is owned or controlled by the assigning Party, such consent shall not be unreasonably withheld or delayed

13. Modern Slavery Act

- 13.1 The Parties deplore modern slavery in all of its forms and are committed to ensuring that their supply chains are free of such practices. As such, the Parties require that their suppliers are vigilant both in their businesses and in their onwards supply chains for any areas of risk in this regard. The Parties assert that they:
 - Have considered the risks of modern slavery being present in their businesses and onwards supply chains; and
 - Have reported any such existing concerns to the other Party and will do so if any arise in future

14. Notice

14.1 All notices which are required to be given under this Agreement shall be in writing and shall be addressed to the Director, Global Business Development of the CISI, Principal or Executive Director of CHRIST COLLEGE and the Director of Finmark to the addresses set out in the first page hereof, or such alternative address as the recipient may designate by notice given in accordance with this clause

15. Disputes

15.1 Any dispute will be escalated to the Chief Executive Officer of the CISI, Dean of CHRIST COLLEGE and Co-Founder & Director of Finmark

16. Termination

- 16.1 This Agreement is valid for one (1) year and may be terminated at any time with 3 (three) months' notice by either party
- 16.2 Upon termination, Finmark shall pay the CISI all outstanding revenue payments for CISI examinations booked against their account code within 10 (ten) days of termination
- 16.3 This agreement will be renewable at the end of the first year for a period of one (1) year subject to agreement by all the three Parties

WHEREAS, The Leibniz Institute for Applied Geophysics (LIAG) is an independent research institute. With geophysical methods we explore structures and processes in the upper part of the Earth's crust that are relevant to and influenced by mankind. Research in the field of Applied Geophysics is important to face challenges of the future such as the exploration, sustainable supply, and conservation of essential natural resources. It is also important to assess geohazards. Our research contributes to achieving the Sustainable Development Goals by the United Nations. LIAG is a public-law institution. It is financed by state, federal, and third-party funds.

LIAG is a member of "Section E: Environmental Research" of the Leibniz Association and is the only institute of the Leibniz Association that explores the upper part of the Earth's crust by using geophysical methods and techniques. Earth system research of the Leibniz Association focuses on the hydro-, litho- and atmosphere; research fields that are closely interlinked with human activities.

WHEREAS,

Christ College, Irinjalakuda was established in 1956. Founded as per the provisions of the Indian Constitution, part III, Article 30(1) and administered by Christ College Educational Society, (Regd. No. 137/75), this college is a Minority institution, affiliated to University of Calicut. The College has since transformed in to a premier educational institution in the state of Kerala, dedicated to the cause of higher education. Following the recommendation from the State government, the College has been conferred with the "Autonomous status" by University Grants Commission (UGC), Govt. of India during the year 2015. For the last two consecutive terms the College was re-accredited with the highest grade (A) by the National Assessment and Accreditation Council (NAAC), Govt. of India, highlighting the merit of the Institution. College comes under the top ranking institutions in the ranking done by National Institutional Ranking Framework (NIRF), Ministry of Human Resource Development, Govt. of India.

The College offers programs such as 22 undergraduate, three professional degrees, 15 post-graduate, six research, two career oriented vocational courses and a post-graduate diploma, managed by over 300 teaching and non-teaching faculty. About 4000 students are currently enrolled in the College under various academic programs. The research departments of the College include Geology and Environmental Science, Zoology, Chemistry, Physics, History, Economics etc. Department of Geology and Environmental Science was established in 1981 and offer two undergraduate program in Geology and two postgraduate programs in Applied Geology and Environmental Science. Department also offers PhD program in Geology and Environmental Science under the University of Calicut. The Department is actively involved in research of various fields in Geology and Environmental Science.

The signatories agree:

Paragraph 1: Common Shared Vision

- 1.1 Signatories of this agreement share the following common vision: the promotion and enhancement of the dissemination of knowledge in order to provide society with superbly trained professionals, and in the creation of knowledge through the scholarly research activities of its faculty, staff and students in order to provide society with the vitally needed highly qualified personnel.
- 1.2. Signatories of this agreement agree in principle to establish for themselves a preferential Institutional partner status.

Paragraph 2. Scope and Objectives

- 2.1 The Department of Geology and Environmental Science, Christ College Autonomous, Irinjalakuda, Thrissur, Kerala, India (hereinafter "Christ College"), and the Leibniz Institute for Applied Geophysics, Federal Republic of Germany (hereinafter "LIAG") have decided to pursue scientific and technical cooperation in the field of Earth system science and technology in accordance with this nonbinding Memorandum of Understanding (hereinafter "MoU").
- 2.2 This MoU is to provide a framework for the exchange of scientific and technical knowledge and the augmentation of scientific and technical capabilities of the Christ College and of the LIAG (hereinafter "party" or "parties") with respect to the science and technology.
- 2.3 Each party may, with the consent of the other, and to the extent permitted by the laws and policies of each government, endeavor to enlist other Indian or German entities to participate in activities undertaken pursuant to this MoU.

Paragraph 3. Cooperative Activities

- 3.1 Forms of cooperation under this MoU should consist of, without limitation, exchanges of technical information, visits, and cooperative research, consistent with ongoing programs of the cooperating parties. Specific areas of cooperation may include but are not limited to such areas of mutual interest as:
 - a. Sedimentology and Geochemistry
 - b. Optically stimulated luminescence (OSL) and Electron Spin Resonance (ESR) dating
 - c. New (geophysical) measurement and assessment technologies
 - d. Hydro- and engineering geology
 - e. Other research areas related both parties
- 3.2 Activities under this MoU should be undertaken in accordance with the laws, regulations, and procedures of each country.

Paragraph 4. Availability of Resources

4.1 Cooperative activities under this MoU are subject to the availability of personnel, resources, and funds. This MoU shall not be constructed to obligate any particular expenditure or commitment of resources or personnel.

Paragraph 5. Accuracy of Information

5.1 Information transmitted by one party to the other under this MoU shall be accurate to the best knowledge and belief of the transmitting party. However,

the transmitting party does not warrant the suitability of the information transmitted for any particular use or application by the receiving or by any third party.

Paragraph 6. Planning and Review of Activities

6.1 Each party may designate a principal representative who, at such times as are mutually decided upon by the parties, shall meet to review the activities under this MoU and develop proposals for future activities, as appropriate.

Paragraph 7. Project Annexes

7.1 The parties shall decide in writing upon any activity carried out under this MoU in advance. Whenever more than the exchange of technical information or visits of personnel is contemplated, such activity shall be described in an agreed project annex to this MoU, which may set forth in terms of appropriate to the activity, a working plan, staff requirements, cost estimates, founding sources and other undertakings, obligations, or conditions not included in this MoU. Except from this, each party works on own costs.

Paragraph 8. Copyright Information

- 8.1 Copyright information used by either party should remain the property of the originator, or the party offering the materials.
- 8.2 Cooperative activities under this MoU are desired and intended to be published in scientific media. The publications are to be done jointly by those who accomplished the work and are to be agreed upon participants in advance.

Paragraph 9. Nature of the MoU

9.1 This MoU is not an agreement under international law; it is not intended to create rights and obligations under international law.

Paragraph 10. Duration

10.1 This MoU will remain effective for five years from the date of signing. It may be renewed by mutual consent, if proposed by either party.

Paragraph 11. Amendment/Termination

11.1 This MoU may be amended or terminated by mutual consent, if proposed by either party, by giving at least six months notice in writing to the other party.

Paragraph 12: Legal Effect

12.1 This MoU is not intended to impose any legal obligation whatsoever on either parties, but not limited to an obligation to bargain in good faith. The parties do not intend to be bound by any agreement until both agree to and sign a definitive written contract. Neither party can rely on any promises inconsistent to this paragraph. This paragraph supersedes all other conflicting terms.

This MoU is written in English and signed in duplicate by both parties. It may be translated into other languages for reference purposes.

Where as the above named institutions recognize that academic collaboration would be of mutual benefit and would strengthen research and education. Hence the mutual interest in engaging in academic cooperation between CHRIST COLLEGE (AUTONOMOUS), Irinjalakuda, Thrissur and the UNIVERSITY OF ZULULAND, KwaDlangezwa.

Purpose/goals of partnership

- i. To strengthen relationships, understanding and appreciation between people in India and South Africa.
- ii. To provide opportunities for students and teachers to develop professional, academic and research skills.
- iii. To develop friendly ties through regular communication.
- iv. To build an international perspective within the Institutes.
- v. To develop students into responsible citizens who are globally engaged, comfortable with diversity and possessing skills to operate effectively across cultures with different world views and belief systems.

The signatories agree:

ARTICLE 1: Common Shared Vision

Signatories of this agreement share the following common vision:

- 1.1. Promotion of faculty and students exchange by each institute for teaching and learning in the areas of Science, Arts and Sports.
- 1.2. Creation and dissemination of knowledge through combined research of faculty and students to provide society with superbly trained professionals.
- 1.3. Facilitation of exchange of culture through mutual visits and participation by partner institutes.

ARTICLE 2: Commitment of the Signatories

2.1. Student exchange programme

- 2.1.1. UNIVERSITY OF ZULULAND and CHRIST COLLEGE (AUTONOMOUS) would offer opportunities to undergraduate and postgraduate students from the partner institution to carry out projects/ internships in their laboratories.
- 2.1.2. Proposals for students must be done in advance and agreed upon with sufficient notice to both parties. The exact number of students will be agreed upon by the two institutions on an annual basis. In any given year, the number of students hosted can vary.
- 2.1.3. The parent institution will be responsible for screening and selecting students, subject to acceptance by the host institution.
- 2.1.4. The host institution will assist the students to obtain accommodation, and with other matters of hospitality, but is not obliged to provide financial assistance of any kind.

- 2.1.5. Participating students shall be responsible for obtaining their own visas and completing the required immigration formalities.
- 2.1.6. Students participating in the programme will pay appropriate tuition fees to their parent institution during the period at the host institution. They will also pay for all personal expenses at the host institution, including visa, accommodation, travel, meals and health insurance. They will be exempted from tuition fees at the host institution.

2.2. Faculty exchange programme

The agreement also envisions co-operation for faculty exchange through deputation for short term assignments spread over not more than a year in areas mutually identified.

2.3. Other activities

The above-mentioned activities are not exclusive; others may be considered, such as:

- · Joint projects,
- Collaborative research activities, including joint supervision of doctoral students.
- · Joint academic programmes,
- · Other areas of mutual interest.

When relevant, the above-mentioned activities will be described in a specific document.

ARTICLE 3: Administrative provisions

- 3.1. UNIVERSITY OF ZULULAND and CHRIST COLLEGE (AUTONOMOUS) agree to appoint an overall coordinator for the administration. The coordinator will serve as the contact person on campus, being responsible for arrangements associated with visits, ensuring that necessary approvals are in place and the general welfare of the students/faculty.
- 3.2. Each party may designate an official from their side to serve as coordinators under this Memorandum of Understanding. Individuals listed as Coordinators may be revised by either party by providing written notice to the current Coordinators.

3.3. Terms and termination

- 3.3.1. This agreement will become effective upon the final date of signing and shall be effective for five (5) years.
- 3.3.2. This agreement shall be renewed if both the parties agree at the end of the five-year-term.
- 3.3.3. The MoU may be terminated by either party by providing 180 days written notice to the co-ordinators listed.
- 3.4. Modification:

If any change in the above clauses or a modification is intended then it can be carried out by mutual consent of both the parties.
